Land Use

Uknadax (Hog Island) is **not included** on the OC Land Use Permit. Please do not recreate at Uknadax without permission from Ounalashka Corporation.

Due to hazardous material and the clean-up effort underway, **Uknadax is not open to the public.**

Rules when using Our Land

The Ounalashka Corporation (OC) is happy to share the beauty of its land with non-shareholders as long as our wishes as landowner are respected and our few rules are adhered to (along with compliance with all City, State and Federal laws). Each non-shareholder that is 18 years or older must have a valid land use permit issued by OC.

The following activities are prohibited on OC lands:

- The use of **explosives, flares, or fireworks** of any kind.
- **Discharging a firearm**, except where a valid Hunting Permit has been issued by OC, and all requirements of the permit as well as all Federal, State, and Local Laws are followed. Only shotguns may be used to hunt on OC lands.
- Use of **off-road vehicles of any type**, including, but not limited to, dirt bikes, motorcycles, all-terrain vehicles, dune buggies, and two- and four-wheel licensed vehicles.
- Use of **snow machines**, unless a valid snow machine permit is obtained. Visit the OC website for the notice of when snow machines may be used based on snow conditions.
- Blocking or otherwise **obstructing a public or private road or trail**.
- Storing, discharging, releasing, and/or spilling any **petroleum product or other hazardous material**.
- **Parking of vehicles**, other than along a permitted public right-of-way or an OC-designated parking area.
- **Littering, waste nuisances, graffiti**, or otherwise disturbing the natural contour of the land. If you pack it in, pack it out.
- **Digging or destruction** of vegetation.
- **Commercial use** of any kind.
- Accessing leased properties.
- **Disturbing archaeological sites** (this is a federal crime and OC will pursue violators to the fullest extent of the law).
- **Building or making a large commercial fire** without a valid burn permit from the City of Unalaska and the consent of Ounalashka Corporation.
- **Building or making a bonfire**, unless it is less than 4' x 4' in size and only if built in a designated/approved bonfire location according to the attached map.
- **Small campfires, barbecues, and warming fires**, unless they are less than 3 feet wide and have flames less than 2 feet high.
- **Trapping**. No trapping of any kind is permitted on any OC lands.

Please be aware UAV photographs, surveillance cameras and aerial drones may be used for the enforcement of land permit rules and regulations.

Hiking. Picnicking. Berry picking. Fishing. Beach combing. Subsistence gathering. Camping.

Unalaskans and visitors to Unalaska can do all of these things and more!

However, much of the land on Unalaska, Amaknak and Sedanka Islands is privately owned by OC, and permission is required to access or cross its land. Without OC's permission you are trespassing. This includes popular areas like **Summer Bay; Humpy Cove; Pyramid Valley; Morris Cove; Mounts Ballyhoo, Pyramid, and Newhall, Eider Point, Ulakta Head; Margaret Bay; and Uknadax** (formerly known as Hog Island).

Any harvesting on OC lands shall be in strict accordance with the OC Harvesting Plan.

Harvesting Plan

ALLOWED HARVESTING ACTIVITIES:

Subsistence harvesting of berries and plants.

PROHIBITED HARVESTING ACTIVITIES:

Commercial use of harvested berries and plants.

RESTRICTED/LIMITED HARVESTING ACTIVITIES:

*Group harvesting, tour groups, and commercial activity require prior notification to OC, a special permit, and may be subject to limitations depending on activity. Contact OC's office at **907-581-1276** for more information.*

To promote sustainable use of resources on OC properties, the following Unangan Values are provided as a guide to harvesting from OC properties:

- Berries that are easy to access are for the elderly to pick.
- Do not over-harvest; only take what you are capable of processing and using for subsistence.
- Do not damage the berry bushes or land in the harvesting process.
