Ounalashka Corporation - Request for Pricing – Landing Craft Transport Services

1. Introduction

Ounalashka Corporation (OC) is seeking proposals from qualified transportation service providers to facilitate the transport of personnel and equipment from Unalaska Island to Broad Bay. The selected provider will be responsible for the safe and efficient delivery of materials and equipment as specified in this RFP.

2. Scope of Work

- Transport personnel, equipment, and materials to and from Broad Bay over a maximum of eight (10) total trips.
- Transport of personnel and equipment from Amaknak Island to Broad Bay must begin no later than 01 April 2025, while transport from Broad Bay back to Unalaska Island will be conducted at an as needed basis with prior coordination.
- Period of Performance: Through September 30, 2025
- Time on shore will range from 2-8 hours.
- Ensure all loading, securing, and unloading operations comply with applicable safety regulations.
- Adhere to all U.S. Coast Guard (USCG) and maritime safety regulations, including:
 - 33 CFR - Navigation and Navigable Waters
 - International Convention for the Safety of Life at Sea (SOLAS)
 - International Maritime Organization (IMO) regulations
 - USCG Vessel Inspection and Safety Management System (SMS) requirements
 - Compliance with the Maritime Transportation Security Act (MTSA)
 - Spill Prevention, Control, and Countermeasure (SPCC) plan adherence
- Provide appropriate vessels, personnel, and logistical planning for the transport.
- Maintain proper recordkeeping of trips, personnel counts, and compliance documentation.

4. Regulatory and Safety Compliance The selected vendor must comply with all relevant regulations, including but not limited to:

- U.S. Coast Guard Regulations:
 - 33 CFR (Navigation and Navigable Waters)
 - Vessel safety and operational guidelines per USCG requirements
 - Current OUPV license.
- Occupational Safety and Health Administration (OSHA) Regulations:
 - Loading and unloading safety procedures
 - Proper securing and lifting mechanisms
- Environmental Protection Agency (EPA) Regulations:
 - Spill prevention and containment measures
 - Protection of marine ecosystems
- Alaska State and Local Regulations:
 - Permits and approvals necessary for maritime transport
 - Compliance with local marine traffic guidelines

- Proposed transportation plan and schedule
- Compliance measures for USCG and safety regulations
- Cost breakdown, including fuel, labor, insurance, and any additional fees
- Proof of necessary insurance, licensing, and certifications

- Cost-effectiveness and pricing structure
- Availability and reliability of transportation services
- Sustainability and environmental impact considerations
